We invite pastors, church leaders, educators, and other professionals committed to the struggle for a just peace in Israel/Palestine to participate in this leadership experience. The aim of this program is to gain a deeper understanding of the current realities in Israel/Palestine as well as to view the Holy Land through a new, biblical/theological lens. This opportunity is open for people already interested in the region, who are committed to making a difference and investing in hope.

The study tour will explore the question: Where do we go from here on the journey toward peace, human rights and building bridges of understanding? The program will highlight the experience of

courageous Palestinians attempting to build a future even in the face of occupation.

The Palestinian Christian community in the 2009 Kairos document sent out a cry to the Christian community abroad saying "Come and See." This invitation is even more urgent in 2017, fifty years after the 1967 war. Come and see the facts on the ground, listen to diverse narratives, be inspired by ministries of hope, and consider future directions for advocacy and support. We hope you will join us for this ecumenical program of faith and learning.

PAYMENT SCHEDULE: Your reservation and deposit of \$400 per person are requested immediately to fulfill the group deadline requirements. Note that space is limited and reservations are taken on a first come, first served basis. A second payment of \$1000 is due June 13, 2017. Final payment is due August 11, 2017. For credit card payment Group Travel Directors accepts Visa, MasterCard, or Discover.

REFUND POLICY: All cancellations must be in writing. There is no refund for partial or unused land arrangements. Note: Airline tickets will be issued well in advance of departure and may be nonrefundable. 


About Our Host

Mitri Raheb and the Diyar Consortium

Born and living in Bethlehem, Palestine, The Rev. Dr.

Mitri Raheb is a world-renown champion of peace. He was ordained as a pastor in the Lutheran church in 1987 and has been serving since as Pastor of Evangelical Lutheran Christmas Church in Bethlehem, Palestine.

He has received a number of international awards including the 2016 Olof Palme Prize, the 2012 German Media Award, the Lux Mundo Award, the 2007 Peace Award of Aachen, and many more.

Widely regarded as the most prolific Palestinian theologian of our times, Raheb has also written numerous books and articles. His book "Faith in the Face of Empire" is a best seller. Raheb has received global media attention from outlets and networks including CNN, ABC, CBS, BBC, The Economist, Newsweek, Vanity Fair and more.

The Rev. Dr. Mitri Raheb is President of the Diyar Consortium, which will host the program and serve as "home base."

About Our Leaders



Mike Abel is a Palestinian-American who has worked in healthcare for most of her professional life. She has traveled to Israel, the West Bank and Gaza many times on peace and medical missions. In 2009, she was part of a diplomatic pilgrimage

with the is Council for the National Interest, visiting five Middle Eastern countries and Israel. In 2011, she spent three months on her own work-study program in Palestine/Israel. Currently, she is on the board for Delaware Churches for Middle East Peace. She is the co-founder of DelNATO (Delaware Neighbors Against the Occupation) and the recipient of the 2014 Peacemakers Among Us Award from Pacem in Terris. Through her advocacy work, she presents to a wide range of audiences, students, churches, and peace/justice organizations on the current environment in Palestine and Israel. Most recently she has returned from Bethlehem, Palestine, where she participated in a leadership conference.



John Lindner is retired as Associate Dean for External Relations, Yale Divinity School. He spent over a quarter century providing leadership for international, ecumenical/interfaith programs for the PCUSA, the National Council of Churches (NCCUSA) and the World Council of Churches (WCC). He served as writer for the task force that produced the NCCUSA's Middle East Policy (1980). He first traveled to the Middle East in March 1974 and was an intern in Beirut with the Middle East Council of Churches in 1975. Over the years, he has traveled many times to the Middle East; served on the Leadership Council of Churches for Middle East Peace and was on the Board of A Different Future. Currently, he volunteers with Bright Stars of Bethlehem as coordinator of the annual Leadership Program and as editor of the blog: "Peace Doers... building a future in Palestine."



Susan P. Wilder is an ordained Presbyterian minister. She is a member of National Capital Presbytery and has served several churches in Northern Virginia. She currently serves as a consultant to the Faith Forum on Middle East Policy, a network of Christian denominations and organizations working for a just peace in the Middle East. She has organized and led several pilgrimage study tours to Israel/Palestine. Susan is a member of the Israel/Palestine Mission Network of the Presbyterian Church (USA) and is on the Advisory Council of the Friends of Tent of Nations, North America. She has served in ecumenical and interfaith networks as a grassroots organizer, speaker, and educator, working to raise awareness about the Israeli/Palestinian situation and to promote avenues for constructive engagement and advocacy.

The program will be based in Bethlehem in comfortable accommodations in the Lutheran Guesthouse and a local hotel with many of the meals at the award winning Il'lliyeh Restaurant at the International Center of Bethlehem. The Leadership Program will include visits to various parts of the occupied West Bank of Palestine and to Jerusalem where the group will meet with outstanding religious, academic, business and political leaders for briefings and discussions. It is important to note that this program is organized in a travel seminar/program format, so opportunities for tourism will be limited. The price is based on a minimum of twenty-two travelers. In the event enrollment falls under the minimum, an increase of \$200 per traveler will apply (with seventeen to twenty-one travelers). Speakers listed in the brochure have been invited, although the program is subject to change.
