DAY-BY-DAY ITINERARY

SAT 15 JUN

Depart U.S.

Depart Chicago O'Hare for your overnight flight to Tel Aviv. (Meals in-flight)

SUN 16 JUN

Tel Aviv/Bethlehem

Upon arrival in Tel Aviv, meet your guide and driver and transfer to Bethlehem for hotel check-in. After time to rest and refresh, gather for a welcome dinner. Abu Gubran Lutheran Guesthouse (Meals in-flight, D)

MON 17 JUN

Bethlehem

Drive to the Separation Wall and view checkpoints through which Palestinians must travel to leave or enter the West Bank. Meet with a representative at the Environmental Education Center on a Lutheran school campus in nearby Beit Jala. Visit Tent of Nations farm and the Israeli settlement of Efrat to hear from a community leader. Stop at Shepherds' Field where you will view Bethlehem as the shepherds might have on the night of Jesus' birth. There will be an opportunity for shopping at the olivewood cooperative there. Enjoy dinner at The Grotto Restaurant. Abu Gubran Lutheran Guesthouse (B,D)

TUE 18 JUN

Bethlehem

Meet Angie Saba this morning to learn about the varied ministries of the Diyar Consortium, and tour the International Center of Bethlehem (ICB) and Dar al-Kalima University College. Meet The Rev. Dr. Mitri Raheb for conversation and lunch. This afternoon enjoy a walking tour of the Old City of Bethlehem, including the Church of the Nativity. Abu Gubran Lutheran Guesthouse (B,L,D)

WED 19 JUN

Bethlehem/Nazareth

Stop to visit Yad Vashem, the Holocaust Memorial in Jerusalem before driving northward to Nazareth. Upon arrival visit the Church of the Annunciation; the lower level contains the Grotto believed by many Christians to be the remains of Mary's original childhood home. Check in at your hotel, for dinner and overnight. Golden Crown (B,D)

THU 20 JUN

Nazareth

Begin the day viewing the first-century "Jesus Boat," dug out of the mud of the Sea of Galilee. Sail across the Galilee waters to Capernaum, where Jesus' ministry began. Visit the Ancient Synagogue and the church built over Saint Peter's house, where Jesus healed Peter's mother-in-law. Drive

The Holy Land is a place that conjures many images in our minds – from inspiring to confounding. I have travelled there three times previously, and each trip was a life-changing experience. This journey will be a pilgrimage in which we will follow in the footsteps of Jesus, seeing the lands of the Bible. Throughout the trip we will share group reflection, prayer and worship. As meaningful as the holy sites will be, I believe our unique encounters with the people who live there today may be even more moving. We will learn what it is like to be a Christian in this sacred and chal-

lenged land of many faiths, and we will see firsthand the remarkable ministry of the Lutheran church and others who are creating opportunities for hope, healing and peace. We will have good accommodations, delicious meals and expert guides. I hope you'll join me in this trip of a lifetime!

along the shore for visits to the Church of Multiplication (miracle of loaves and fishes), the Church of the Primacy of Peter, and the Church of the Beatitudes, one of the most beautiful in Galilee. On the return trip to Nazareth, visit Mt. Tabor known as the site of Jesus' transfiguration. Golden Crown (B,D)

FRI 21 JUN

Nazareth/Jerusalem

Early morning departure for the town of Jayyous. Meet with town leaders, hosted by the Ecumenical Accompaniment Program in Palestine and Israel (EAPPI). Continue to Jerusalem to meet with an ELCA representative of Lutheran World Federation at the Augusta Victoria Hospital campus on the Mount of Olives. Check in at your hotel for a three-night stay. Lutheran Guesthouse or Knight's Palace (B,D)

SAT 22 JUN

Jerusalem

Savor the stunning panoramic view of Jerusalem from the Mount of Olives and walk down the Palm Sunday Road to the Garden of Gethsemane and the Church of All Nations. Walk through the Old City's Muslim Quarter, along the Via Dolorosa (Way of the Cross), to the Church of the Holy Sepulchre. Stroll along the Cardo, the Roman era main street. This evening hear from a representative of Rabbis for Human Rights, ICAHD or B'tselem. Lutheran Guesthouse or Knight's Palace (B,D)

SUN 23 JUN

Jerusalem

Early this morning look upon the Western Wall, one of the holiest sites in the Jewish tradition, then visit the Temple Mount/Haram al Sharif to view the golden Dome of the Rock, an important symbol of the Muslim faith. Join in the English-language worship at the Lutheran Church of the Redeemer, then gather for coffee and fellowship with members of the congregation and meet the ELCA English language pastor. Enjoy exploring and shopping in the Old City. Lutheran Guesthouse or Knight's Palace (B,D)

MON 24 JUN

Jerusalem/Petra

After hotel check-out, cross over the Allenby Bridge to Jordan and meet your Jordanian guide, driver and coach. Visit Bethany-beyond-the-Jordan, which has received recognition as the likely site where John baptized Jesus, and the nearby Lutheran church and chapel. Drive to Mount Nebo where Moses viewed the Promised Land; enjoy the dramatic view of the Jordan Valley, Jericho and the Judean hills beyond. Continue through the vast desert to the village of Wadi Musa, which embraces the entrance to Petra – one of the Seven Modern Wonders of the World. Petra Guesthouse (B,D)

TUE 25 JUN

Petra/Amman/Departure

Two thousand years ago the Nabateans carved a city out of rose red rock and it was rediscovered in 1812. You will discover the formerly lost city of Petra during a half-day guided tour. Begin by walking through the dramatic "ciq" or canyon that opens upon the Treasury, El Khazneh, one of the most elegant remains of antiquity. Beyond El Khazneh the visitor is surrounded on both sides by hundreds of Petra's carved and built structures. This afternoon travel to Amman for a festive farewell dinner at Kan Zaman Restaurant. This atmospheric restaurant is house in a walled village inside a historic Caravansérai, a former inn for travelers of centuries past. Enjoy a Middle Eastern feast and music. Following dinner, proceed to the airport for check-in and flight departure before or after midnight. (B,D)

WED 26 JUN

Return to U.S.

Arrive home today enriched with your discoveries of faith and friendship in the Holy Land. (Meals in-flight)

TOUR CONDITIONS

PAYMENT SCHEDULE: Your reservation and deposit of \$400 per person are requested immediately to fulfill the group deadline requirements. Note that space is limited and reservations are taken on a first come, first served basis. A second payment of \$1000 is due February 8, 2019. Final payment is due April 9, 2019. The fee for late payment is \$50 per person. For credit card payment Group Travel Directors accepts Visa, MasterCard, and Discover.

REFUND POLICY: All cancellations must be in writing. There is no refund for partial or unused land arrangements. Note: Airline tickets will be issued well in advance of departure and may be nonrefundable. The following penalties will apply: Up to February 7, 2019 - \$100 per person administrative fee plus any unrecoverable deposits; February 9 - May 30, 2019 - Deposit plus any unrecoverable payments to hotels, tour operators or airlines; May 31, 2019 or after - No refund.

CHANGES TO GROUP FLIGHTS: The group airfare contract for this tour may not allow travelers to make any date or itinerary changes. If you are considering other dates or cities, please submit your request in writing well in advance to secure the best rates and schedule, but no later than February 8, 2019. A minimum fee of \$100 per person will apply for changes to group flights in addition to a possible airfare increase.

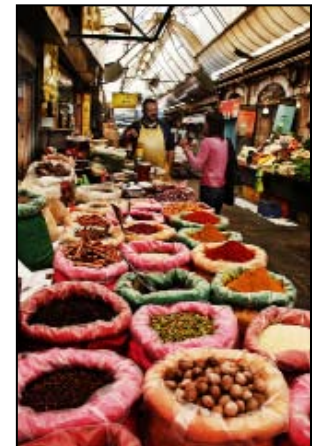
